- Port waters or specific routes
- Practical application of local port regulations
- Collision regulations
- Port reporting procedures
- Safety and crisis management
- Buoyage system
- Shiphandling proficiency

PRE-REQUISITE REQUIREMENTS

Shipmasters are required to complete the relevant movements required for issue of the Pilotage Exemption Certificate.

CERTIFICATION: Satisfactory completion of this Assessment would meet part of requirements for the issue of a Pilotage Exemption Certificate by MPA.

DURATION: 4.5 Hours (0.5 hours written assessment & 4 hours familiarization/assessment)
